- 4. If your company or you have applied for the Hotel Sponsorship Programme or any other buyer sponsorship programmes of Hong Kong International Optical Fair 2024 or any concurrent fair, this application will not be processed.
- 5. Each company is entitled to ONLY ONE OFFER OF TRAVEL REIMBURSEMENT. This offer is available on a first-come-first-serve basis.
- 6. Applications without attaching a photocopy of the applicant's business card will not be processed. Your company information must be identical to the information on your application form.
- 7. Once your application has been approved, we will send the acknowledgement letter to you within 4 working days. If you do not hear from us within 4 working days, your application is considered as unsuccessful.
- 8. Successful applicants must show up in the fair and complete a questionnaire when collecting the reimbursement at the "Buying Mission Service Counter" in the fairground.
- 9. You must visit the fair and collect customised stamps from the "Buying Mission Service Counter" in order to be qualified for the incentive. **Only 1 stamp can be collected on each fair day.**
- 10. The original copy of the acknowledgement letter, passport with landing slip, business card, boarding pass and e-ticket receipt MUST BE presented upon the reimbursement collection. HKTDC reserves the right to reject any reimbursement requests should there be any informational discrepancies on the passport, landing slip, boarding pass and e-ticket receipt.
- 11. HKTDC reserves the rights to vary the terms and conditions, change or terminate the sponsorship programme without any prior notice. In case of any dispute over the programme, the decision of HKTDC shall be final and binding.
