- For any usage of compressed air, it **MUST** be booked through and provided by the Hong Kong Convention and Exhibition Centre. **For any exhibitors with self-brought compressed air (those who did not order from the Hong Kong Convention and Exhibition Centre), their machinery will be prohibited from operation.**
- For exhibitors with machinery as exhibits, a certificant for annual inspection **must be provided**.
- Please be informed that the Organiser will request exhibitors with bulk exhibits to move-in earlier than normal move-in date & time. Exact move-in date & time will be announced later. If the exhibitor fails to move-in their exhibits at the specified date & time set by the Organiser, the Organiser has the right to refuse their exhibits to be moved into the exhibition hall.
