5. If your company or you have applied for the Hotel Sponsorship Programme or any other buyer sponsorship programmes of concurrent fair, this application will not be processed.

9. You must show up at the HKTDC Hong Kong International Optical Fair 2025 and complete a buyer survey when collecting the Travel Reimbursement Voucher at the "Buying Mission Service Counter". The person collecting the Voucher and the stamps must be the same person applying for this programme.
10. Applications without attaching a photocopy of the applicant's business card will not be processed.
11. Your application is subject to review by HKTDC. Once your application has been approved, we will send the acknowledgement letter to you within 5 working days.
12. The original copy of acknowledgement letter, passport with landing slip, business card, boarding pass and e-ticket receipt **MUST BE** presented upon the reimbursement collection. The HKTDC reserves the right to reject any reimbursement requests should there be any informational discrepancies on the passport, landing slip, boarding pass and e-ticket receipt.
13. The HKTDC reserves the rights to vary the terms and conditions, change or terminate the sponsorship programme without any prior notice. In case of any dispute over the programme, the decision of HKTDC shall be final and binding.
