



Travel Reimbursement for Overseas Buyers

9. You must show up at the HKTDC Hong Kong International Optical Fair 2026 and complete a buyer survey when collecting the Travel Reimbursement Voucher at the "Buying Mission Service Counter". The person collecting the Voucher and the stamps must be the same person applying for this programme.
10. Applications without attaching a photocopy of the applicant's business card will not be processed.
11. Your application is subject to review by HKTDC. Once your application has been approved, we will send the acknowledgement letter to you within 5 working days.
12. The original copy of acknowledgement letter, passport with landing slip, business card, boarding pass and e-ticket receipt **MUST BE** presented upon the reimbursement collection. The HKTDC reserves the right to reject any reimbursement requests should there be any informational discrepancies on the passport, landing slip, boarding pass and e-ticket receipt.
